- Failure on the part of the bidder to fill in and/or to sign the forms and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory a Board of Auditors (IRBA) or an Accounting Officer as contemplated in Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- The institution reserves the right to require of the bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim regarding preferences, in any in manner required by the institution.

2. GENERAL DEFINITIONS

- 2.1 **"Acceptable bid"** means any bid which, in all respects, complies with the specifications and conditions of bid as set out in the bid document.
- 2.2 **"Bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods, works or services.
- 2.3 **"Comparative price"** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration.
- 2.4 **"Consortium or joint venture"** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skills, and knowledge in an activity for the execution of a contract.
- 2.5 **"Contract"** means the agreement that results from the acceptance of a bid by an organ of state.
- 2.6 **"Specific contract participation goals"** means the goals as stipulated in the preferential Procurement Regulations 2001
- 2.7 **"Control"** means the possession and exercise of legal authority and power to manage the assets, goodwill, and daily operations of a business. And the active and continuous exercise of appropriate managerial authority and power in determining the policies and directing the operations of the business.
- 2.8 **"Disability"** means, in respect of a person, a permanent impairment of a physical, intellectual, or sensory function, which results in restricted, or lack of, ability to perform an activity in "the manner, or within the range, considered normal for a human being.
- 2.9 **"Equity Ownership"** means the percentage ownership and control, exercised by individuals within an enterprise.
- 2.10 **"Management"** means an activity inclusive of control and performed daily, by any person who is a principal executive officer of the company, by whatever name that person may be designated, and whether or not that person is a director.

- 2.11 "**Owned**" means having all the customary elements of ownership, including the right of decision-making and sharing all the risks and profits commensurate with the degree of ownership interests-as demonstrated by an examination of the substance, rather than the form of ownership arrangements.
- 2.12 "**Person**" includes reference to a juristic person.
- 2.13 "**Rand value**" means the total estimated value of a contract in Rand denomination that is calculated at the time of bid invitations and includes all applicable taxes and excise duties.
- 2.14 "Small, Medium, and Micro Enterprises (SMMEs) bears the same meaning assigned to that expression in the National Small Business Act, 1996 (No 102 of 1996).
- 2.15 "**Sub-contracting**" means the primary contractors assigning or leasing or making out work to, or employing another person to support such primary contractor in the execution of part of a project in terms of the contract.
- 2.16 "**Trust**" means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person.
- 2.17 "**Trustee**" means any person, including the founder of a trust, to whom property is bequeathed for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1. The bidder obtaining the highest number of points **will not necessarily** be awarded the contract.
- 3.:1 Preference points shall be calculated after prices have been brought to a comparative basis
- 3.3 Points scored will be rounded off to 2 decimal places.
- 3.4 In the event of equal points scored, the procurement committee will consider other factors as they may deem necessary in promotion of Black Economic Empowerment, College procurement policy and incubator initiatives.

Failure to reach consensus:

- 3.4.1 All qualifying tenderers will be called to a special briefing session to submit their best and final offer.
- 3.4.2 No information relating to individual tenders will be revealed.
- 3.4.3 The briefing will cover the identified gaps only.
- 3.4.4 The committee may decide to enter into negotiation with the preferred bidder relating to any matter taken in the bid documents.

4. POINTS AWARDED FOR PRICE

4.1.1 THE 90/10 PREFERENCE POINT SYSTEMS

A maximum of 90 points is allocated for the price on the following basis.

- 5.2. Registered auditors do not need to meet prerequisite for IRBA's approval for the purpose of conducting verification and issuing EME's with B-BBEE status level.
- 5.3. A trust, consortium, or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE certificate.
- 5.4. **Any person awarded a contract may not sub-contract more 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability to execute the sub-contract.**

CERTIFICATE OF INDEPENDENT BID DETERMINATION

1. This Standard Bidding Document (SBD) must form part of all bids invited.
2. Section 4 (1) (b) (iii) of the competition Act No.89 of 1988 as amended, prohibits an agreement between, or concerted practice by firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). Collusive bidding is a per se prohibition meaning that it cannot be justified under any grounds.
3. Treasury Regulation 16A9 prescribes that Accounting Officers and Accounting Authorities must take all reasonable steps to prevent abuse of the Supply Chain Management System and authorizes Accounting Officers and Accounting authorities to:

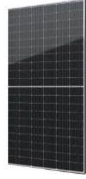

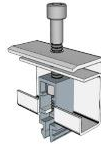

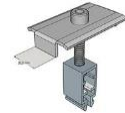
